### WATER DEPARTMENT REPORT:

Per JD bacteriological water samples were good for the month of November. Usage for the month was 1,049,000 gallons, spring depth was 15" and temperature was 36 degrees. Repaired a water main leak #5 for the year on Crescent Drive; no price yet from Lopez for dig. Reordered repair clamp used for repair. Worked on the WTP and the TCR reports and sent them off to the State Water Board. Also worked on the generator log during the month. Put up hydrant marker poles with the fire volunteers, also put up valve marker poles. Repaired a pin hole in pump seal lubrication line. Purchased a new saws all for water main repairs. Signed up for two classes in December for T2 and D2 licenses. Purchased spare line and parts for pump room lubrication feed. Assisted in locating and delivery of fire siren.

#### FIRE DEPARTMENT REPORT:

Chief Hunter reported they had three regular drills for the month. There was one medical call in Clear Creek. One firetruck is down and working on getting a mechanic out to evaluate and fix it.
