WATER DEPARTMENT REPORT:

Steve Sader reported there was a power outage the 1st of the month that lasted 15 minutes. On May 11, we had an earthquake. The spring was cloudy so we increased the chlorine dose. On May 12, a boil water notice was ordered. A water sample was taken and delivered to Redding Lab on Friday, May 12. On Monday, May 15, the boil water notice was lifted. Customer had a broken pipe on Clear Creek Drive, turned off the water & turned it back on when the customer fixed. Usage for the month was 1,718,030 gallons, spring height is at 25 ½ ". There is a seismometer by the side of the Firehouse buried by the USGS. They will collect it in 2 weeks. They are studying Mt Lassen. Picked up the 16 jugs of chlorine in Reno.

FIRE DEPARTMENT REPORT:

Chief Ross Kassebaum reported there was 1 medical in Clear Creek. Went to CPR 1st Aid training. Nicki & I will be attending drivers training for driving emergency vehicles the next 2 weekends.

INFORMATION / DISCUSSION ITEMS:

- 1. Water System Improvements Project update Nicki noted a new Water Operator, Steven Sader was hired. She will provide contact information to all. Anne Kernkamp retired last week, so Randy Marx has taken back the project. On 4/14/23, Anne submitted the request for UEI Budget to UEI and we are awaiting this Budget. Following receipt, Randy will package this up with the draft Work Plan and provide to DFA for review. Nicki noted that issues with the springhouse continue to be a concern.
- 2. Green Waste Days is scheduled for June 14 17 2023

CLOSED SESSION: Rod Twain reported the board was going into closed session to discuss personnel issues at 6:23 pm. Out of closed session at 7:20 pm Rod Twain reported, the board referred the complaint to the Fire Chief. Board approved a 10% one-time salary increase for Nicki Moroney/General Manager/Secretary/Treasurer effective July 1, 2023.
