Note that the higher of the CPI factor or growth in commercial and industrial assessed Value is used in the calculation. This calculation will be cited in the sample approval resolution given below. Only appropriations of proceeds of taxes are subject to the limit. Other revenue sources can be appropriated without affecting the calculation. The County Accounting Standards and Procedures Committee issued Guidelines in 1990 describe the calculation of appropriations subject to the limit. If the amount of appropriations subject to the limit is more than the limit, the difference must be refunded to the taxpayers, or voter approval must be obtained for a higher limit.

RESOLUTION ESTABLISHING FISCAL YEAR 2026-2027 APPROPRIATION LIMIT UNDER ARTICLE XIII B OF
THE CALIFORNIA CONSTITUTION AND ESTABLISHING PERIOD FOR CONTESTING SUCH LIMITS FOR THE
BOARD OF DIRECTORS OF CLEAR CREEK COMMUNITY SERVICES DISTRICT.

WHEREAS , Article XIII B of the California Constitution provides that the state and each local
government shall be subject to an annual appropriation limit as defined in that Article; and

WHEREAS, Article XIII B Section (e) (2) requires the Governing Body to select the change in Cost-
of-Living methodology each year by recorded vote; and

WHEREAS, the percentage change in California Per Capita Income provides the greatest result
rather than using the change in the Local Assessment roll from the preceding year due to the addition of
non-residential new construction; and

WHEREAS, the Auditor-Controller of the County of Lassen has computed the appropriations limit for the fiscal year 2026-2027; and

WHEREAS, the Auditor-Controller of the County of Lassen has prepared the application Statements showing the calculation and such detail statements are available for public review during reasonable hours and after reasonable notice in the Auditor-Controller's Office.

NOW, THEREFORE, BE IT RESOLVED, that the County of Lassen selects the percentage change in California Per Capita Income and the percentage change in the population of the contiguous counties methodology for use in calculating its appropriation limit for fiscal year 2026-2027; and

BE IT FURTHER RESOLVED, that, the appropriations limit for Clear Creek Community Services District for the fiscal year 2026-2027 as shown on Attachment "A" is hereby established as \$376,043 and that such appropriations limit may be adjusted at a later date in the event that revenues which are unanticipated, and classified as proceeds of taxes in accordance with Section 8 (e) (2) of Article XIII B of the California Constitution, as received and appropriated,

BE IT FURTHER RESOLVED that any judicial action or proceeding to attach, review, set aside, void or annul the appropriation limits established by this resolution shall be commenced within 45 days from the date of the resolution is accordance with Division 9 of the Government Code.
