Water Department February 28, 2022 balance \$92,625.05(March 2022 deposits \$12,328.02) (March 2022 expenditures \$4,208.63) March 31, 2022 balance \$100,744.44

Reviewed & motion to approve financials was made by Rod Twain, seconded by Jessica Greene, all in favor, motion carried.

WATER DEPARTMENT REPORT:

JD reported water samples were good for the month. Getting bids to load test the generator. Exercising main valves, marking location and painting lids. Handed out 2 week shutoff notices. Shut off valve to customer at customers request. Located buried water box for seller customer, broken line in house that had frozen early on. Asked customer to install own valve through plumber. Shut off another customer that had lateral broken by logging. Working on spring report field data for 2021 also working on March WTP and TCR reports. Water usage for March was 231,000 gallons, spring intake depth is 16 inches. Working with tree cutting crew to clear site for tree removal for our new pump room and other trees near firehouse as well. Checking water boxes as they appear from the snow. Takin classes to keep T2 and D2 licenses.

FIRE DEPARTMENT REPORT:

Chief Hunter reported there were 4 regular drills and 1 medical call for the month of March. Attended a chiefs meeting in Susanville and came away with a MCI (mass casualty incident) bag and plenty of PPE for Covid-19 for free. No status change for engine 1121, still waiting on the motor.

INFORMATION / DISCUSSION ITEMS:

- 1. Repairs on Engine 1121 discussed above.
- 2. Wildfire Community Preparedness Day is Saturday, May 7, 2022 for 9 am until noon. Everyone is invited to come to the firehouse; the volunteer firefighters will be handing out brochures on how to prepare your home for wildfires. This is a national annual campaign that encourages people and organizations to come together on the first Saturday in May to take action to raise awareness and reduce wildfire risks.
- 3. The update on the tree removal is Tubit Enterprises, Inc. (contractor) has been hard at work for the past 5 weeks. They are working on approximately 49 parcels, climbing or falling trees. They have scheduled the crane for April 18. Nicki has been instructed not to collect anymore exemptions at this time. Tom Esgate with the Lassen Fire Safe Council has requested an additional \$100,000 from PG&E to continue this much needed hazard/fuel reduction project.

- 3. Motion to approve filing a lawsuit with McNicholas & McNicholas Becker Law Group for the Dixie Fire was made by Julie Raymond, seconded by Jessica Greene, all in favor, motion carried.
